VitalStim[®] FAQs



Are there any other accredited courses for NMES for Dysphagia?

No. The only accredited NMES for Dysphagia course is the *VitalStim/DINES Specialty* course. It was accredited through Institute for Credentialing Excellence (ICE) and meets National Commission for Certifying Agencies (NCCA) standards.

What if I did not attend VitalStim training by CIAO?

You must pass the VitalStim competency program in order to use a VitalStim device and implement the VitalStim Protocols. The safety and improvement of patients and the protection of your licensure are important to us. No matter what device you decide to use, CIAO Seminars STRONGLY recommends being trained in that device and protocol and you maintain documentation of that successful training.

Once I am a VitalStim Provider, can I train others or sign off on VitalStim competencies?

No. On the bottom of all VitalStim certificates, it states that the successful completion of the course does not qualify the certificate holder to train or deem others competent. There is a specific list of competencies which must be validated by a qualified instructor. Those documents are maintained to provide legal support for any Provider who may be called into question. These competencies are part of the FDA clearance. Professional Boards require training to be given by someone who is an expert in the field as well as in adult learning processes. The only approved VitalStim Instructors are listed on CIAO's website. All VitalStim education, including the manual, clipboard, placements and protocols are copyrighted to CIAO Seminars. If Providers would like to use any part of the VitalStim manual, they will need to contact CIAO for a temporary license release. Copyright protection includes domestic as well as international territories.

I am a VitalStim Provider, can I train others or sign off on competencies for another device?

It is not recommended! As an ethics instructor, the owner of CIAO Seminars stresses the importance of protecting yourself as a therapist and as an individual. Unless you know the specific competencies for the other device, treatment protocols, indications, contraindications, precautions, warnings and detailed FDA clearance allowances and have permission to use their copyrighted information – DO NOT!

Can I use the VitalStim device without training?

As part of the initial FDA application, the manufacturer guaranteed that all VitalStim device users would be trained though an independent education company and independent instructors (CIAO Seminars). This is written in the VitalStim device user manual. In addition, ASHA's Code of Ethics require all SLPs to be trained prior to using a device or representing themselves as being trained. The instructor must be an expert in the field as well as experienced in adult learning processes. Centers for Medicare & Medicaid Services (CMS) states that "only qualified professionals with specific training and experience in this ...provide evaluation and treatment"

I have not been trained in VitalStim before, can I take the VitalStim Plus course?

No, the Plus course is the follow-up advanced course to the initial VitalStim and DINES Specialty Certificate. The VitalStim Plus course will not teach you theory, placements, how the treatment works or how to determine what placements and exercises based on signs, symptoms and impairments. Those who successfully pass the Specialty Certificate competency course may use the VitalStim component of the Plus device only. Therapists must complete the Plus course In order to use all components (all 4 channels, biofeedback, sEMG; sEMG with triggered stim, VMS, etc.) of the VitalStim Plus device.

Who sells VitalStim equipment and electrodes?

What does it mean to be "current?"

VitalStim Providers who have received their Specialty Certificate or renewed within the last three years.

If I am not "current", am I still a VitalStim Provider?

Why is there a 3 year requirement to be listed on the Registry?

As part of the national accreditation of the VitalStim Therapy Specialty Program, a 3 year renewal was implemented to meet NCCA standards. This requirement also allows the public searching for potential Providers in their area to find therapists who are familiar with up-to-date research, placements, protocols, indications, contraindications and safety guidelines.

Why am I not on the registry?

If you are a current VitalStim Provider, you should be listed by your facility's zip code. If you are not, please verify your CIAO profile and ensure you are not designated to be "unlisted." Call CIAO, we are happy to help get you there!

How can I update my information?

Can I be trained by a Sales Representative?
